Procedures for shareholders to propose a person for election as director

In accordance with Bye-law 85 of the Bye-laws of the Company, any shareholder of the Company ("**Nominating Shareholder**") who wishes to nominate a person ("**Candidate**") to stand for election as a director of the Company at any general meeting of the Company must lodge with the Company at its head office ^{Note 1} or at the registration office (i) a written notice ^{Note 2} signed by the Nominating Shareholder of intentions to propose the Candidate for election; (ii) a written confirmation signed by the Candidate of his/her willingness to be elected as director and consent to the publication of his/her personal data; (iii) the biographical details of the Candidate as required under Rule 13.51(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited; and (iv) the contact details of the Candidate, within the period of at least 7 days commencing on the day after the despatch of the notice of the general meeting and ending no later than 7 days prior to the date of such meeting (or such other period as may be determined and announced by the Company's directors from time to time).
